

FONTAINBLEAU LAKES COMMUNITY DEVELOPMENT DISTRICT REGULAR BOARD MEETING OCTOBER 21, 2024

A. CALL TO ORDER

District Manager Armando Silva called the October 21, 2024, Regular Board Meeting of the Fontainbleau Lakes Community Development District (the "District") to order at 6:37 p.m. in the Las Ramblas Clubhouse Conference Room located at 9960 NW 10th Terrace, Miami, Florida 33172.

B. PROOF OF PUBLICATION

Mr. Silva presented proof of publication that notice of the Special Board Meeting had been published in the *Miami Herald* on July 15, 2024, as legally required.

C. ESTABLISH A QUORUM

Mr. Silva determined that the attendance of Chairperson Edward Aparicio, Vice-Chairperson Mayra De Torres and Supervisors Humberto Jovanovic, Miguel Garcia (arrived at 6:45 p.m.) and Arno Lemus constituted a quorum and it was in order to proceed with the meeting.

Staff in attendance were: District Manager Armando Silva and Associate District Manager Pablo Jerez of Special District Services, Inc.; and General Counsel Liza Smoker of Billing, Cochran, Lyles, Mauro & Ramsey, P.A.

Others in attendance were: Angel and Esteban Garcia, Miami, FL; Jesus Carcasses, Miami, FL; Mario Echevarria, Miami, FL; Rosalia Echevarria, Miami, FL; Guillermo Cuadra, Miami, FL.

D. ADDITIONS OR DELETIONS TO THE AGENDA

The following items were added to the agenda:

- New Business: Discussion Regarding Parking Rules
- New Business: Discussion Capital Improvements Fund

E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

F. APPROVAL OF MINUTES

1. August 19, 2024 Special Board Meeting & Public Hearing Minutes

Mr. Silva presented the minutes of the August 19, 2024, Regular Board Meeting and Public Hearing. A **motion** was made by Ms. De Torres, seconded by Mr. Aparico and passed unanimously approving the minutes of the August 19, 2024, Special Board Meeting and Public Hearing, as *amended*, thus revising the name of General Counsel in attendance to "Liza Smoker" (agenda item $C.-2^{nd}$ paragraph).

G. OLD BUSINESS

1. Update Regarding Perimeter Fence

Mr. Silva invited Messrs. Carcasses and Echevarria to discuss their concerns over the installation of a perimeter fence in the NW Open Space Quadrant in which a lengthy discussion ensued. They cited "Keep The Bleau Green" citing it as historic area and a detrimental installation as well as an eyesore designed to restrict the access to the open space area from the neighboring residents who have a right to the area. Board Member Mr. Lemus responded by citing the several security issues that has affected the Las Ramblas Community over the last couple years and the community has a right to protect its residents. Mr. Silva also commented that the fence design will have open ingress and egress to provide access to the public. As discussion ensued after which Messrs. Carcasses and Echevarria said they would be open to discussing the project further to come to an agreement at the next meeting.

2. Discussion Regarding Engineering Services Relating to the Perimeter Fence Project

Mr. Silva presented the proposal from Robayna and Associates Inc. for the Stockpile Sampling and Boundary and Tree Survey.

A **motion** was made by Mr. Lemus, seconded by Ms. De Torres and unanimously passed approving the proposal from Robayna and Associates Inc. and the District, pertaining stockpile sampling and Boundary and Tree Survey for the installation of the fence project areas throughout the District, for an amount no to exceed \$18,000.

H. NEW BUSINESS

1. Consider Resolution No. 2024-06 – Adopting a Fiscal Year 2023/2024 Amended Budget

Mr. Silva presented Resolution No. 2024-06, entitled:

RESOLUTION NO. 2023-07

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE FONTAINBELAU LAKES COMMUNITY DEVELOPMENT DISRICT AUTHORIZING AND ADOPTING AN AMENDED BUDGET ("AMENDED BUDGET"). PURSUANT TO CHAPTER 189, FLORIDA STATUES; AND PROVIDING AN EFFECTIVE DATE

Mr. Silva read the title of the resolution into the record and provided an explanation for the document. He further stated the Operating Fund as of September 30, 2024, had a positive balance. A discussion ensued regarding the increased legal cost due to the fence project.

A **motion** was made by Ms. De Torres, seconded by Mr. Garcia and unanimously passed to approve and adopt Resolution No. 2024-06, *as presented;* thereby setting the amended/revised finial budget for the 2023/2024 Fiscal Year.

2. Discussion Regarding Parking Rules

In Las Sevillas individuals are taking up guest parking space with unregistered third parking spaces. The Las Sevillas Homeowners Association is requesting to use the CDD owned parking spaces located outside the community for 90 days. The Las Ramblas Community is requesting the suspension

of rule 1.4 of the Amended District Parking Rules and allow temporary parking rules on Holidays that's been used yearly and add additional areas for guest parking.

A **motion** was made by Ms. De Torres, seconded by Mr. Garcia and unanimously passed to temporarily suspend District Parking Rule 1.3 within Tract R (for 90 days) and District Parking Rule 1.4 within Tract A (during the Holiday Season).

3. ADD-ON: Capital Improvements Fund

Mr. Garcia was requesting the Capital Improvements Funds be split and designated to the corresponding communities, identifying the funds from Las Ramblas and Las Sevillas, respectively. Mr. Silva responded it will be visible in the Fiscal Year 2024/2025 Final Budget.

I. ADMINISTRATIVE & OPERATIONAL MATTERS

Ms. Smoker reminded the Board members to complete their ethics training and submit confirmation to Mr. Silva. Ms. Smoker also reminded that small project agreements for non-government entities must sign a non-coercion affidavit.

K. BOARD MEMBER & STAFF CLOSING COMMENTS

There were no Board member or staff closing comments.
