

### FONTAINBLEAU LAKES COMMUNITY DEVELOPMENT DISTRICT SPECIAL BOARD MEETING SEPTEMBER 3, 2025

### A. CALL TO ORDER

District Manager Armando Silva called the September 3, 2025, Regular Board Meeting of the Fontainbleau Lakes Community Development District (the "District") to order at 6:42 p.m. in the Las Ramblas Clubhouse Conference Room located at 9960 NW 10<sup>th</sup> Terrace, Miami, Florida 33172.

### B. PROOF OF PUBLICATION

Mr. Silva presented proof of publication that notice of the Special Board Meeting had been published in the *Miami Herald* on August 25, 2025, as legally required.

### C. ESTABLISH A QUORUM

Mr. Silva determined that the attendance of Chairperson Mayra De Torres, Vice Chairperson Humberto Jovanovic and Supervisor Arno Lemus constituted a quorum and it was in order to proceed with the meeting.

Staff in attendance were: District Manager Armando Silva of Special District Services, Inc.; and General Counsel Liza Smoker of Billing, Cochran, Lyles, Mauro & Ramsey, P.A.

### D. ADDITIONS OR DELETIONS TO THE AGENDA

There were no additions or deletions to the agenda.

### E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

### F. APPROVAL OF MINUTES

1. June 16, 2025, Regular Board Meeting & Public Hearing Minutes

Mr. Silva presented the minutes of the June 16, 2025, Regular Board Meeting & Public Hearing. A **motion** was made by Mr. Lemus, seconded by Mr. Jovanovic and passed unanimously approving the minutes of the June 16, 2025 Regular Board Meeting & Public Hearing, as presented.

### G. OLD BUSINESS

1. Update Regarding Perimeter Fence Project (Las Ramblas)

Mr. Silva informed the Board and residents that Miami-Dade County continued to review the perimeter fence permit. The Plans Review Department has requested a Zoom meeting with he and the project engineer on September 8<sup>th</sup> to address questions that may help expedite approval.

He also reported ongoing correspondence from Keep the Bleau Green, whose representative, Mr. Mario Echevarria, had expressed opposition to the project and announced the involvement of a new attorney (Alex Migrosso). They are requesting that the District stop the project and meet with them to discuss it.

After discussion, the Board agreed that District Counsel should contact Keep the Bleau Green's attorney, advising that the group is welcome to attend any Board meetings. The Board also recommended obtaining a quote for zoning attorney services if needed.

Mr. Silva will update the Board following his meeting with the County on September 8th.

**Note:** At this point, a **motion** was made by Ms. De Torres, seconded by Mr. Lemus, and unanimously approved recessing the meeting for a brief restroom break at 7:57 p.m. The meeting reconvened at 8:03 p.m.

### H. NEW BUSINESS

1. Interlocal Access Agreement – Advertisements and Public Notices on County Designated Websites

Mr. Silva explained that he would like to discuss the District's required publications and the costs associated with them. Mr. Silva stated that his office had been in communication with the Miami-Dade County (the "County") Communications and Customer Experience Department to determine if advertising on the County's website complied with Florida Statutes. It has been determined that advertising on the County's website meets Florida Statute requirements and the County's attorney has authorized entering into an Interlocal Agreement with Community Development Districts. A discussion ensued after which;

A **motion** was made by Mr. Lemus, seconded by Mr. Jovanovic and unanimously passed to approve entering into the Interlocal Access Agreement with Miami-Dade County.

2. Consider Resolution No. 2025-06 – Interlocal Access Agreement and Authorized Signatories

Mr. Silva presented Resolution No. 2025-06, entitled:

### **RESOLUTION NO. 2025-06**

A RESOLUTION OF THE FONTAINBLEAU LAKES COMMUNITY DEVELOPMENT DISTRICT (THE "DISTRICT") RELATING TO THE INTERLOCAL ACCESS AGREEMENT FOR LOCAL GOVERNMENT PUBLICATION OF LEGAL ADVERTISEMENTS AND PUBLIC NOTICES ON COUNTY DESIGNATED WEBSITE; APPROVING SAME; PROVIDING FOR AUTHORIZED SIGNATORIES; AND PROVIDING FOR AN EFFECTIVE DATE

Mr. Silva stated that District Counsel's firm had prepared a resolution authorizing the District Manager, Chair, or Vice Chair to execute an Interlocal Agreement (the "ILA") between the District and the County on behalf of the District to be able to publish the District legal notices on the County website and any other document related to the ILA. A discussion ensued after which;

A **motion** was made by Mr. Lemus, seconded by Mr. Jovanovic and unanimously passed to approve and adopt Resolution No. 2025-06, as presented.

### I. ADMINISTRATIVE & OPERATIONAL MATTERS

### 1. 2025 Legislative Update Memo (BCLMR)

Ms. Smoker explained that her firm annually prepares a memorandum summarizing the legislative acts that had become law during the most recent legislative session. Ms. Smoker provided the Board an explanation of the laws that pertain to the District. She further informed the Board that if they had any questions regarding these new laws, they may contact her office or the District Manager.

### J. BOARD MEMBER & STAFF CLOSING COMMENTS


Ms. De Torres requested stepping down as the Chairperson for the District and recommended the following slate of names for election:

A **motion** was made by Ms. De Torres, seconded by Mr. Jovanovic and passed unanimously to *elect* the District's Officers, as listed above.



# SITE PLAN FOR


